Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of SSC-95 & HSC-97 FOUNDATION which comprise the Statement of Financial Position as at 31 December 2023 and the related Statement of Income & Expenditure, Statement of Receipts & Payments for the period ended 31 December 2023 and notes to the financial statements.

In our opinion, the accompanying financial statements present fairly in all material respect, the financial position of SSC-95 & HSC-97 FOUNDATION as at 31 December 2023 and of its financial performance for the period then ended in accordance with International Financial Reporting Standards (IFRSs) and comply with the applicable laws and regulations.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the auditors' responsibilities for the audit of the financial statements section of our report. We are independent of the foundation in accordance with the International Ethics Standards Board for Accountants Code of Ethics for Professional Accountants (IESBA Code) together with the ethical requirements that are relevant to our audit in the financial statements in Bangladesh, and we have fulfilled our ethical responsibilities in accordance with the IESBA code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of this financial statements in accordance with IFRSs, and other applicable laws and regulations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Those charged with governance are responsible for overseeing the Foundation's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high-level assurance, but it does not guarantee that an audit conducted in accordance with ISAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements.



Notes to the Financial Statements For the period ended 31 December 2023

1 Background of the Organization

The SSC-95 & HSC-97 Foundation was registered in Bangladesh under the Societies Registration Act of 1860 with Registration No. S-13917/2022 on October 26, 2022. Its registered office is located at Masum Plaza, House-13 (12th Floor), Road-15 (Robindro Sarani), Sector-3, Uttara, Dhaka-1230, Bangladesh. The SSC-95 & HSC-97 Foundation is a private, non-political, non-profit, charitable organization dedicated to serving the needy and distressed sections of society. The Foundation focuses on providing charitable and humanitarian assistance to the public, particularly targeting poor families, orphans, individuals with disabilities, poor patients, and students from low-income families.

2 Objectives

- 2.1 Conducting any philanthropic or charitable activities among poor people;
- 2.2 To establish schools, colleges and universities and undertake the activities of teaching literature, arts and science;
- 2.3 Undertake relief distribution activities among neglected poverty-stricken people;
- 2.4 Undertake/adopt training measures for increasing the efficiency of uneducated and semieducated human groups by adopting educational activities in advanced methods;
- 2.5 To take an active interest in the over all welfare of the community including but not necessarily limited to civic, recreational, cultural, social environmental and security aspects of life an living;
- 2.6 Inform the public/poor community/human society about their beneficial activities/to do;
- 2.7 Creating awareness among common people (illiterate and semi-literate) about developing reading habits by establishing libraries/classrooms;
- 2.8 Among all the candidates of SSC 1995 and SSC 1997, those who are incompetent and their family members are self-reliant and conduct activities for their overall welfare and rehabilitation;
- 2.9 Efforts to get support and assistance from any person, organization and organization and government for implementation of any program run;
- 2.10 To improve the quality of Islamic education by establishing mosques/madrasas and providing free books to poor scholars and ulama;
- 2.11 Undertake education and mass education activities with the aim of spreading education in national life;
- 2.12 Arranging publication and promotion of newspapers, bulletins, magazines, news images, video documentary films according to government sales with the aim of publishing accurate information and activities for the development of the organization and the country etc.

On 11 May 2023 Foundation Governing Body declared Pritesh Talukder as Founder of SSC 95 HSC 97 foundation.


